

HERE-TURI-KŌKA 2025



- Understand whether iwi or hapū in your district and region want to develop Mana Whakahono agreements.
- Understand how a Mana Whakahono ā Rohe could interact with existing documents and agreements.

- Identify resources to support Mana Whakahono agreements.
- Develop a process to respond to an initiation letter.
- Use Guidance to inform council staff and councillors about Mana Whakahono purpose and responsibilities.

- If council is initiating, send a letter to relevant iwi/hapū and other council partners, setting out: key issues, timing and location of hui, etc.

- Council can choose to respond only to the initiating iwi authority, or to advise other iwi authorities or local authorities who may wish to participate.

- Discuss and confirm agreement for the timeframe and process for negotiating a Mana Whakahono and how other authorities may be part of the process.

- Agree which authorities will enter into the Mana Whakahono.
- Understand how existing processes work for iwi/hapū.
- Identify examples of best practise processes for your council.
- Consider examples from existing Mana Whakahono agreements, Joint Management Agreements or other agreements.

- Mana Whakahono agreement must be concluded within 18 months of initiation, unless parties agree otherwise.
- Determine process for sign-off by council officers or councillors.
- Publish and launch Mana Whakahono agreement.

- Identify ongoing resources to support implementation of agreement.
- Review internal policies and processes to be consistent with the Mana Whakahono agreement.

- Agree process for reviewing the agreement every six years, or sooner if there is new content to add to the agreement.

- Me mārama mēnā rānei e hiahia ana ngā iwi, ngā hapū rānei i tō rohe, i tō takiwā hoki ki te whakawhanake i ngā whakaaetanga Mana Whakahono.
- Me mārama ki te āhua ka pāhekoheko pea tētahi Mana Whakahono ā Rohe ki ngā tuinga me ngā whakaaetanga o nāianei.

- Tautohua ngā rauemi hei tautoko i ngā whakaaetanga Mana Whakahono.
- Whakawhanaketia he tukanga ki te urupare ki tētahi reta whakaara.
- Whakamahia He Kupu Ārahi: Guidance - Councils hei whakamōhio ki ngā kaimahi a te kaunihera rātou ko ngā kaikaunihera mō te take me ngā haepapa o Mana Whakahono.

- Mēnā e whakaarahia ana e te kaunihera, tukuna tētahi reta ki ngā iwi/hapū e hāngai ana, ki ērā atu hoa patui kaunihera hoki, e whakatakoto nei: i ngā take matua, i te wā me te wāhi o te hui, i te aha atu anō hoki.

- Ka taea e te kaunihera te kōwhiri ki te urupare anake ki te mana ā-iwi nā rātou i whakaara ake, ki te whakamōhio atu rānei ki ērā atu mana ā-iwi, kaunihera rānei ka hiahia pea rātou ki te whai wāhi mai.

- Whakatauria te wā me te tukanga mō te whiriwhiri i tētahi Mana Whakahono, me te āhua ka whai wāhi pea ērā atu mana ki te tukanga.

- Whakaaetia ko ēhea ngā mana ka uru mai ki te Mana Whakahono.
- Me mārama ki te āhua o te rere o ngā tukanga o nāianei mō te iwi/hapū.
- Tautohua ngā tauira o ngā tukanga tikanga tino pai mō tō koutou kaunihera.
- Whai whakaarohia ngā tauira nō ngā whakaaetanga Mana Whakahono o nāianei, nō ngā Joint Management Agreements, nō whakaaetanga kē atu rānei.

- Me whakaoti te whakaaetanga Mana Whakahono i roto tonu i te 18 marama i te whakaaranga ake māna ka whakaaetia kētia e ngā rōpū.
- Whakatauhia te tukanga mō te waitohutanga e ngā kaimahi kaunihera, e ngā kaikaunihera rānei.
- Whakaputaina, whakarewaina hoki te whakaaetanga Mana Whakahono.

- Tautohua ngā rauemi haere tonu hei tautoko i te whakatinanatanga o te whakaaetanga.
- Arotakehia ngā kaupapa here ā-roto me ngā tukanga kia hāngai mai ki te whakaaetanga Mana Whakahono.

- Whakaaetia te tukanga mō te arotake i te whakaaetanga ia te ono tau, i mua i tērā rānei mēnā he kiko hou hei tāpiri atu ki te whakaaetanga.
